What is the purpose of this update?

This document tells you how the Kernel Global Infrastructure Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel Global Infrastructure Fund invests in globally listed pure-play infrastructure companies and is designed to track the Dow Jones Brookfield Global Infrastructure Index (NZD).

What are the risks of investing?

Risk indicator for the Kernel Global Infrastructure Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Kernel Global Infrastructure Fund are charged fund charges. In the year to 31 March 2021 these are estimated to be:

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Emma had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 December 2020, Emma incurred a loss after fund charges were deducted of \$576.25 (that is -5.76% of her initial \$10,000). This gives Emma a total loss after tax of \$604.25 for the period.
